A number of concerns were raised and suggestions made, some regarding pedestrian access at the railway bridge into Windmill and Litchard Cross, about the road signs that are obstructive at the Heol y Gorsedd junction with Litchard Terrace and about the tree at Litchard Mission. Councillor Young offered to make a referral regarding the obstructive signs to BCBC.

The next step is to look at what needs to be reported back to BCBC add police comments and more back up information. It was agreed to ask if the report could be an agenda item at the next PACT meeting and ask if the feedback could be minuted.
