### FR28/17 TO RECORD THE ACCURACY OF THE MINUTES OF THE FINANCE & RESOURCES COMMITTEE MEETING HELD ON 1st FEBRUARY 2018

#### FR32/17 TO DISCUSS THE FUNDING OF A SUMMER PLAY SCHEME

The Full Council had agreed in principle and had asked this Committee to look at the budget to see if the funding could be found and report back to Full Council in May for a decision.

Resolved: It was agreed to recommend to Full Council that some funding could be saved from the Member Allowances budget line to fund this scheme.

#### FR33/17 TO DISCUSS PROCRUEMENT

#### FR34/17 TO DISCUSS THE TOWN AND COMMUNITY COUNCIL FUND APPLICATION

Disappointingly this year's application had been unsuccessful and a discussion on how the project could be funded took place.

Resolved: It was agreed to recommend to Full Council that the full funding for the scheme could be found by reviewing the budget and using the money put aside for the Asset Transfer as this project has been delayed.

#### FR35/17 TO DISCUSS COUNCIL PROMOTION VIA LEAFLET AND ASSOCIATED COSTS

Ideas were discussed.

Resolved: It was agreed to recommend to Full Council that a full colour newsletter should be drafted and distributed to every household in the 3 wards. The Clerk would look into suppliers and costs.

#### FR36/17 CONFIDENTIAL MATTERS RELATING TO STAFF (PUBLIC TO BE EXCLUDED)

Resolved: It was agreed to recommend to Full Council that an informal review would take place each October between the Chair, Vice-Chair, Clerk and Asst. Clerk. That if there was a grievance by the Clerk this would be looked at by the Vice-Chair, Asst Clerk and 1 Other and if there was a grievance by the Asst Clerk this would be look at by the Chair, Clerk and 1 other. It was agreed to recommend that the Clerk consults with One Voice Wales regarding the recommended hours and salary for a precept of £110k for both staff members.
