FR02/18 TO RECORD THE ACCURACY OF THE MINUTES OF THE FINANCE & RESOURCES COMMITTEE MEETING HELD ON 23RD APRIL 2018

The Minutes of the meeting held on 23rd April 2018 were accepted as a true and accurate record; with this, the Chairman duly signed the Minute Book.

FR04/18 TO RECEIVE A YEAR END 2017/18 REPORT

The Financial Officer, P Ley, tabled the year-end figures following internal audit and these were discussed. There were no concerns raised.

Resolved: This was noted.

FR05/18 TO REVIEW THE COUNCIL'S BUDGET AND ANY POTENTIAL RISKS TO THE BUDGET

There were no issues to report. The budget was discussed and reviewed to cover the additional agreed works including the allotment gardens roadway, the refurbishment of the war memorial and the cost of the newsletter. It was recommended that in addition to the £3,000 already allocated in the budget for the allotment gardens that £3,500 from the reserves would be used along with £5,000 from the Community Asset Transfer budget.

Resolved: The budget was reviewed, approved and accepted.

FR06/18 TO DISCUSS PROCRUEMENT

Concerns had been raised about the growth of weeds along the spine roads in the 3 wards and how this could be addressed. They are sprayed by BCBC and left to rot and look very unsightly during this process.

Resolved: It was agreed to put aside £1,000 to pay for the weeds to be cleared as a one-off clearance.

The Allotment Garden rent for 2019/20 was discussed and the costs of improving the garden roadway.

Resolved: It was agreed to recommendation to full council an increase in 2019/20 from £30 to £36 per annum.
