A draft budget was presented to the Finance Committee. Each line entry of the document was discussed and amendments made. It was agreed that a recommendation to Full Council to request a precept of £88,000 would be made for 2018/19 and to set a budget of £110,150 for that year earmarking reserves to make up the difference. This would result in a 39% increase in precept and a rise to £25.10 per dwelling based on council tax Band D equivalent.

Resolved: The draft budget would be amended to reflect the recommendations made and the second draft would be presented to full council at its December precept meeting for further discussion and approval.
