Minute FR39/20 Matters Arising from the November Minutes

The Clerk gave the following updates:

- That the roadway in the allotment gardens had been repaired
- That work to footpath 52/52a Heol Hopcyn John would commence the week beginning 8th February subject to weather conditions. Costs had risen since the quote was obtained by £3,700 and RoW at BCBC had agreed to cover the cost.
- That the tree work to the side of Litchard Park had been completed up to the dog leg area.
- That funding of £1,250 had been secured from Wales & West for the purchase of two picnic tables for Cae'r Eglwys (Coity playing field)
- That permission had been granted in principle by Persimmon to install a noticeboard and defibrillator at Oakwood View

• That the proposed work to create a footpath at Heol Simonston is on hold until the results of BCBC's phase 3 Safer Routes funding application is known as the application contains provision for a permanent path at this location.
